NOTE: There is no limit to the number of eligible members that may apply from a chapter or school. Please submit to the NJ FCCLA State Office no later than March 1, 2019. The selection committee will include a member of the State Staff and two alumni members of FCCLA. The FCCLA State Adviser will be an ex-officio member of the committee. Please be sure to check the appropriate scholarships of which you will be applying and to answer all questions.

## **FCCLA Scholarship Application**

A maximum of two \$300 scholarships will be awarded. The first will recognize a student pursuing a career in a Family and Consumer Sciences Related Occupation, and the second to a student with outstanding leadership abilities. The criteria are as follows:

- Must be a twelfth grade student and an active FCCLA member for the current school year.
- Must be a member who has been involved in community activities.
- Must submit a transcript.
- Must submit written references from the guidance counselor and FCCLA chapter adviser.
- Must submit proof of application to post-secondary education with guidance counselor's recommendation.

## **NJ Friends of FCCLA Scholarship**

Friends of FCCLA will award a \$300 scholarship to one outstanding member of Family, Career, and Community Leaders of America based on their exceptional commitment to the state organization, demonstration of leadership abilities, involvement in community affairs, and evidence of strong character and integrity.

- Must be an active senior member of NJ FCCLA
- Must demonstrate leadership activities and community service actions.
- Must exhibit strong character and integrity through personal actions
- Must intend to join and anticipate promoting the Friends of FCCLA/Alumni program.
